OFFICE ORDER

Whereas The District Court, Aizawl, Mizoram has, in its judgement order against Civil Suit No. 06 of 1996 in the case of United Pentecostal Church, North East India versus The State of Mizoram etc. on the issue of Registration of The United Pentecostal Church of Mizoram resolved/ held that the name of United Pentecostal Church of Mizoram is identical with or resembles the name of United Pentecostal Church, North East India and hence cannot be registered under The Societies Registration (Extension to Mizoram) Act, 1976 as the then in force law and also under Section 11 of The Mizoram Societies Registration Act, 2005.

And whereas the General Secretary, United Pentecostal Church of Mizoram has, in his representation vide No. A. 1012/G-1/12-MUPC/II/6 dt 01.07.2024 expressed consent for cancellation of registration in the light of court judgement and order. The registration of the United Pentecostal Church of Mizoram bearing No. SR-53/97/MZ-RFS of 14.5.1997 with its postal address at Zonuam, Aizawl is, therefore, cancelled with effect from the date of issue of this order.
